4.0 DETAIL

- 4.1 The Council has a statutory duty under the Gaelic Language (Scotland) Act 2005 to develop and deliver a Gaelic Language Plan. The Council's current plan runs from 2022-2026.
- 4.2 The Plan aligns with the National Gaelic Language Plan and has been subject to approval by Bòrd na Gàidhlig, the principal public body in Scotland responsible for promoting Gaelic development and who also advise Scottish Ministers.
- 4.3 The Council delivers the plan using both internal resources and also grant funding from Bòrd na Gàidhlig, which is made specifically available to support Gaelic Language Plan delivery and development. Officers are in the process of applying for a 3-year grant to support plan delivery.
- 4.4 A number of Council services are involved in delivering actions relating to the Gaelic Language Plan including Education, Development and Economic Growth, Community Planning and Development and Communications as well as Roads and Infrastructure Services and Property Services.
- 4.5 The progress report attached provides detail as required by Bòrd na Gàidhlig in the form of their standard report template. It gives details on the wide range of activities that the Council is involved in to support the Gaelic Language in Argyll and Bute. The Council's role spans both direct delivery and the facilitation, support and enabling of community groups and members who have an interest in Gaelic.
- 4.6 The Council manages an active Gaelic Forum Facebook group that continues to attract members and is open to all. Members who are interested can find the group on Facebook.
- 4.7 A cross service officer group meets on a regular basis to share updates and monitor progress on the actions in the plan.
