1. APOLOGIES FOR ABSENCE

Apologies were received from Councillor Ann Horn.

2. DECLARATIONS OF INTEREST

Councillor Robin Currie declared a non financial interest in relation to the Voluntary Sector Grant 2009-2010 application received from the Columba Centre, Islay ICCI, he left the room and took no part in the discussion of this application which is dealt with at item 11 of this Minute.

3. MINUTES

The Minutes of the Mid Argyll, Kintyre and the Islands Area Committee held on 8 April 2009 were approved as a correct record subject to the following amendments:-

Item 4 – Public and Councillor Question Time

It was noted that Councillor Donald Kelly had asked for clarification from Strathclyde Police regarding the practice of illuminating signs on Police vehicles.

Item 14 – Remaining Capital Works – Mid Argyll, Kintyre and Islay

It was noted that decision 2 of this item should have read "The Contracts Manager agreed to clarify and provide Councillor Currie with details of the £20,000 for lay-bys in the Carradale area".

4. PRESENTATION BY SCOTLAND TRANSERV

The Chair welcomed Simon MacLeod, Area Manager, Scotland Transerv, and his colleagues to the meeting to discuss issues affecting the A83 trunk road.

Decision

- 1. After responding to a number of questions raised by Members the Committee noted:
 - a) That Scotland Transerv planned to spend £4.4m on the A83 during 2009/2010 which was 11% of their overall budget for 2009/2010:
 - b) that Scotland Transerv would arrange to provide Members with a note of their planned programme of works for 2009/2010;;
 - that works on the Rest and Be Thankful were scheduled to commence in February 2010 and design works were also being undertaken for a road widening scheme at Erines;
 - d) that Scotland Transerv would discuss with the Council's Head of Roads and Amenity Service arrangements for copying Members into correspondence between Scotland Transerv and Officers in respect of issues raised by Members;
 - e) that Scotland Transerv would investigate the problems of igress of water between Stonefield and Ardrishaig, and the flooding at Furnace, and report back to Members with their findings;
 - f) that Scotland Transerv would also investigate the problems of igress of water at Arrochar; and
 - g) that Scotland Transerv would investigate complaints about vibrations affecting households next to the Minard traffic lights due to a large number of pot holes in that location;
- Acknowledged the work recently carried out by Ennstone Thistle on the A83 north of Tarbert and agreed that appreciation of this should be relayed to the company; and
- 3. Thanked Scotland Transerv for their informative presentation and looked forward to feedback on issues raised at decision 1 above.

5. TARBERT ACADEMY: ACHIEVEMENT REPORT 2008

The Chair welcomed Catriona Hood, Head Teacher of Tarbert Academy, to the meeting to give a presentation on progress, developments and pupil achievements since she joined the school in 2008 and outlined plans for the year ahead.

Decision

To offer congratulations for the strong performance of pupils and the commitment of staff in their examination successes and in the wider aspects of achievement across the school.

6. PUBLIC AND COUNCILLOR QUESTION TIME

Councillor Donald Kelly advised that following the Committee's visit to Campbeltown Grammar School earlier in the day, it was important that the problems encountered by the school in respect of the condition of the building were recognised and, at the request of Councillor Kelly, the Chair agreed to write to the Leader of the Council requesting that a full Council or Executive meeting be held in Campbeltown at the earliest opportunity and that arrangements be made for Members to visit the school on the same day.

Councillor Donald Kelly asked that the Area Corporate Services Manager write to Strathclyde Police asking for clarification on whether or not all of the Police force were trained and authorised to drive at speeds exceeding the limit in built up areas when on route to traffic accidents/emergencies. This followed a complaint Councillor Kelly had received from a constituent regarding the speed of a police vehicle travelling through the town of Campbeltown on route to a recent traffic accident. The Area Corporate Services Manager agreed to raise this issue with Strathclyde Police.

7. PLANNING APPLICATIONS

(a) **09/00225/DET**

Co-operative Group. Detailed Application. Erection of Class 1 Retail Foodstore. Land at Lorne Street, Lochgilphead

Decision

To agree that planning permission be granted subject to the conditions and reasons outlined in the report and subject to condition 4 detailed in the report being amended to read:-

"Prior to development commencing, a scheme for the proposed boundary treatment along the frontage of the site with the A83(T) shall be submitted to and shall be approved in writing by the Council as Planning Authority. This shall provide for a combination of a natural stone dyke with associated hedgerow planting. A sample of the stone proposed for use shall be submitted to and approved by the Council as Planning Authority prior to construction of the wall being commenced, and the wall shall be completed before the building is first occupied. The associated hedge shall be implemented in the first planting season following the completion of the wall. In the event that this fails to become established, or is removed, becomes seriously diseased, or dies within 10 years of being first planted, it shall be replanted in the subsequent planting season with the same

numbers, sizes and species as originally required to be planted".

(b) **09/00246/DET**

Mrs W Nairn, Detailed. Replacement of static caravan with a dwelling house. Caravan at Bardarvine (opposite Woodhouse), A83(T) south of Tarbert.

Decision

1. To note that the following conditions detailed in the report have been amended as detailed below:-

Condition 3 – First sentence to read "Prior to the first occupation of the dwelling, the gradient of the access road shall not exceed 1 in 25 metres for a distance of 5 metres from the nearside edge of the trunk road carriageway, and the first 5 metres shall be surfaced in a bituminous surface and measures shall be adopted to ensure that all drainage from the site does not discharge on the trunk road".

Condition 5 – delete "construction" and insert "first occupation" and delete last sentence.

Condition 9 – substitute with "The site shall be landscaped in accordance with the details shown on drawing no. 17480-101 A 'Landscaping' with the phased removal of conifers and replacement deciduous planting taking place in the locations shown, in accordance with a phasing plan to be submitted to and approved in writing by the Council as Planning Authority within 3 months of the first occupation of the dwelling. This shall provide that all the replacement planting indicated shall be implemented within 3 years of the first occupation of the dwelling"; and

2. To agree that planning permission be granted, subject to the conditions outlined in the report and to the amended conditions detailed above, and as a 'minor departure' to the adopted Development Plan.
