## 8. Monitoring and Review

This Plan needs to be flexible with an ability to adapt to changing pressures such as climate change, new technologies, new information and legislation.

The Marine (Scotland) Act introduces a new system of marine planning for Scotland which requires a National Marine Plan and allows Regional Marine Plans to be developed. Marine planning at the regional level may be undertaken by Marine Planning Partnerships for specific Scottish Marine Regions and this plan will be integrated into any future planning system.

#### 8.1 Implementation and Review

The Loch Etive ICZM plan aims to provide guidance for Local Authority planners, other regulators, and stakeholders on the future use and development of the marine waters and surrounding coast of Loch Etive for the next five years (2011 – 2016).

Argyll and Bute Council's Marine and Coastal Development Unit will undertake the following throughout the Plan period:

- Continue to coordinate the Loch Etive ICZM group and organise and facilitate meetings where appropriate;
- Facilitate implementation of Plan recommendations;
- Update and revise the plan where necessary;
- Encourage and assist in the development of research projects that will aid future management of Loch Etive, and
- Continue to increase awareness and understanding of Loch Etive and its management.

### 8.2 Monitoring

Argyll and Bute Council will monitor the implementation of this Plan and its effectiveness on an ongoing basis. The monitoring will assess:

- Development applications for marine and coastal development in the coastal zone of Loch Etive to determine whether they were consistent with plan policies;
- Feedback on the extent to which the Plan has been used and referred to by developers and regulatory authorities, and
- Feedback from local stakeholders, communities, developers, and regulatory authorities on how useful and user-friendly the plan is.

It is anticipated that a short monitoring report will be produced by the Marine and Coastal Development Unit on an annual basis to assist frequent review of the Plan.

### 9. Action Plan

The following actions have been identified from recommendations detailed in sections 5 and 6 of the Plan and the requirements for monitoring and review outlined in Section 7. This five year action plan will be reviewed annually and implemented by the Council's Marine & Coastal Development Unit (MCDU) in partnership with relevant regulators, stakeholders and other Council departments. Inclusion of actions in this plan does not guarantee that funding will be available.
