

**ARGYLL AND BUTE COUNCIL  
(DISABLED STREET PARKING – OBAN, LORN &  
THE ISLES)  
(VARIATION)(No.4)  
ORDER 2022**

Argyll and Bute Council in exercise of the powers conferred on them by sections 45 101, 102, and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with a Chief Officer of Police Scotland in accordance with Part III of Schedule 9 to the Act, and having complied with Part II of the Local Authorities’ Traffic Orders (Procedure) (Scotland) Regulations 1999, hereby make the following Order:

- 1 This Order may be cited as the “Argyll and Bute Council (Disabled Street Parking – Oban, Lorn & the Isles) (Variation) (No.4) Order 2022” and shall come into operation on Monday the tenth day of January Two Thousand and twenty-two.
- 2 The Interpretation Act 1978 shall apply for the interpretation of this Order and of all Orders revoked by this Order as it applies for the interpretation of an Act of Parliament.
- 3 Upon the coming into operation of this Order the Order specified in the Schedule to this Order under ‘Name of Order’ shall have effect subject to the amendments specified in the Schedule to this Order under ‘Extent of Amendment’.
