Currently working actively with 429 young people across all of Argyll and Bute. Training to 26 organisations and 114 individuals. In addition represented third sector (and Argyll and Bute on national level) at 108 meetings. Delivered bespoke advice and support to 61 organisations and groups. Hosted 3rd sector forum in 5 areas. Completed first phase community engagement work and results passed to ABC. Twelve staff qualify to deliver accredited CoPE qualifications and range of accredited short courses. AVA has its own accredited EFQM assessor. IJCVS – established inaugural third sector forum. Support to 14 groups. Developing plans with new Manager in post. ABSEN – continued support to social enterprises. New Manager takes up post late January 2011; Bill Stewart. No information available for Bute Community Links.</p>
<p>Key Challenges & Actions to Address</p>	<p>Rising demand and level of enquiries need to be met within resources. As yet unknown level of SG funding to this area. Distribution between partners organisations will impact on service and equitable availability. Strategic Plan to be completed March 2011. All partners taking actions to work towards greater sustainability which is less grant dependent whilst maintaining and improving core activities. Ensuring that future plans reflect identified and evidenced need and respond to changing circumstances which impact on our communities and individuals.</p>
