### 2. DECLARATIONS OF INTEREST

#### 3. MINUTES

The Minutes of the CHORD Programme Management Board meeting held on 5 August 2010 were approved as a correct record.

### 4. ASSESSMENT OF OBAN BAY MARINE REVISED PROPOSAL

The CHORD Programme Management Board resumed consideration of the findings of the assessment, carried out by the Council's Consultants, of the revised proposal received from Oban Bay Marine following the decision of the Programme Management Board on 6 January 2010 and the subsequent recommendation received from Oban CHORD Project Board following their meeting held on 19 August 2010.

#### Decision

The CHORD Programme Management Board unanimously endorsed the decision of the Oban CHORD Project Board and agreed that:-

1. Having regard to the advice received by the Council's consultants, with particular reference to capital and revenue funding, the project

should not proceed any further; and

2. The remaining project options referred to in the Outline Business Case and Project Initiation Document are now explored to utilise the CHORD funding allocation of £900k with a report regarding project options being presented to the Oban CHORD Project Board no later than November 2010.
