- (b) the determination of any matter affecting the authority, (whether, in either case, proceedings have been commenced or are in contemplation).

**Paragraph 13** Information which, if disclosed to the public, would reveal that the authority proposes-

- (a) to give under any enactment a notice under or by virtue of which requirements are imposed on a person; or
- (b) to make an order or direction under any enactment.
