### Operating Plan

The premises will operate on-sales only with proposed licensed hours of 1200-2230 (Mon-Fri) and 1200-2200 (Sat & Sun).

### Activities

The activities will be Restaurant Facilities and Recorded Music. The recorded music will be background music and radio only.

### Children & Young Person Access

The applicant and LSO have agreed on the following wording for the consideration of grant by the Board –

#### Terms

*Children of all ages and young persons will be allowed access in the company of a person aged 18 years or over when buying food to sit in.*

#### Ages

*Children – birth to 15 years*

*Young Persons – 16 & 17 years*

#### Times

*Children of all ages and young persons will be allowed access until 2200 and in the company of a person aged 18 years or over when buying food to sit in.*

#### Parts

*All public parts of the premises.*

20 persons
