

# NOTICE OF ELECTION

## UK Parliamentary Election – Thursday 4 July 2024

### Argyll, Bute and South Lochaber constituency

1. An Election is to be held for of a Member of Parliament to serve the above constituency.
2. Nomination papers can be obtained from the office of the Returning Officer, Kilmory, Lochgilphead, Argyll, PA31 8RT by downloading a pack from [UK Parliamentary Election - 4th July 2024 | Argyll and Bute Council \(argyll-bute.gov.uk\)](https://www.argyll-bute.gov.uk/uk-parliamentary-election-4th-july-2024) calling 01546 603264 or emailing [elections@argyll-bute.gov.uk](mailto:elections@argyll-bute.gov.uk) .
3. Nominations papers must be delivered to the Returning Officer at The Election Office, Council Offices, Kilmory, Lochgilphead, Argyll PA31 8RT on any working day after the date of this notice, on Monday to Friday 10 am to 4 pm (excluding bank holidays) **but no later than 4pm on Friday 7 June 2024**.
4. A person shall not be validly nominated as a candidate unless the sum of £500 is deposited by that person, or on that person's behalf, with the Returning Officer at the place and during the time for delivery of nomination papers. The £500 deposit can be paid by legal tender, by means of a Banker's Draft (provided the drawer carries on business as a banker in the United Kingdom); or the electronic transfer of funds.
5. If the election is contested the poll will take place on **Thursday 4 July 2024** between 7am and 10pm.
6. **Applications to register to vote** must reach the relevant Electoral Registration Officer at the below noted address by **12 midnight on Tuesday 18 June 2024**. Applications can be made online at [www.gov.uk/register-to-vote](https://www.gov.uk/register-to-vote).
7. **New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote** arrangements must reach the relevant Electoral Registration Officer at the below noted address by **5 pm on Wednesday 19 June 2024**.
8. **Applications for a Voter Authority Certificate or an Anonymous Elector's Document** valid for this election must reach the relevant Electoral Registration Officer at the below noted address by **5pm on Wednesday 26 June 2024**. 9. **New applications to vote by proxy** at this election must reach the relevant Electoral Registration Officer at the below noted address by **5pm on Wednesday 26 June 2024**
10. **Applications to vote by emergency proxy** at this election must reach the relevant Electoral Registration Officer at the below noted address by **5pm on Thursday 4 July 2024**.
