UK PARLIAMENTARY ELECTION ARGYLL, BUTE AND SOUTH LOCHABER COUNTY CONSTITUENCY

DAY OF ELECTION – 4 JULY 2024 NOTES FOR PROSPECTIVE CANDIDATES

The following notes are for the guidance of prospective candidates. More election information is available at the Argyll and Bute elections website www.argyll-bute.gov.uk/elections

1. Poll

The notice of election will be posted on the Argyll and Bute elections website above. In the event of a contest polling will take place on Thursday 4 July 2024. The hours of poll will be 7.00 am to 10.00 pm.

2. Nomination Paper

Nomination papers completed and subscribed in accordance with the provisions of the Parliamentary Election Rules must be delivered by the candidate, or by their proposer or seconder, or by their election agent if the agent's name and address have previously been given to the **Returning Officer**, at the Election Office, Kilmory, Lochgilphead, Argyll, PA31 8RT on any working day between the hours of 10.00 am and 4.00 pm beginning on Monday 3 June and ending at 4.00 pm on Friday 7 June 2024.

The nomination paper must be signed by two electors as proposer and seconder, and by eight other electors as assenting to the nomination. "An elector" means a person who is registered as a Parliamentary elector in the Constituency in the Register to be used at the election. Their electoral number must be as appearing in the Register of Electors. The terms "distinctive letter(s) or numbers" under the heading "Electoral number" refers to the Polling District reference shown on the front of the Register, eg AA54, followed in the right hand column with the elector's own number.

A person is not permitted to sign as a proposer, seconder or assentor on more than one nomination paper at the same election and, if they do, their signature will be inoperative on any paper other than the one first delivered. A person cannot subscribe the same nomination paper in more than one capacity (ie proposer, seconder, assentor).

A person whose name is entered in the Register of Electors may not subscribe a nomination paper if the entry given as the date on which they will become of voting age is a date later than the day fixed for the poll. In the case of this election, only those electors who attain 18 years of age by 4 July 2024 may subscribe a nomination paper.

It is essential that the nomination paper should be completed fully and accurately. Incomplete or inaccurate papers may be rejected.

3. Home Address Form

A candidate may request that their home address be not made public and their address will not appear on the statement of persons nominated and on the ballot paper if requested. If you choose not to make your home address public, you must describe the exact name of the constituency (or country, if outside the UK) of your address. This will appear on the statement of persons nominated and on the ballot paper.

4. Candidate's Consent to Nomination

A person is not validly nominated as a candidate unless their consent to nomination:-

- (a) is given and dated in writing on, or within one month before, the day fixed as the last day for the delivery of nomination papers;
- (b) is attested by one witness; and
- (c) is delivered at the place, and within the time, for the delivery of nomination papers.

A candidate's consent must -

- (a) state the day, month and year of their birth; and
- (b) must state
 - (i) that they are aware of the provisions of the House of Commons Disqualification Act 1975; and
 - (ii) that to the best of their knowledge and belief they is not disqualified from membership of the House of Commons.
 - (iii) That they are not a candidate at an election for any other UK Parliamentary constituency within the same polling day.

A copy of the House of Commons Disqualification Act 1975 as amended is available for inspection at the Election Office.

The attention of prospective candidates is also drawn to the updated disqualification orders for candidates, updated by the Elections Act 2022.

5. Candidate's Description

The particulars of a candidate given in a nomination paper may, if desired, include the word "Independent". A description need not be included, but if it is, it will be printed on the ballot papers and in the Notice of Poll. (See also Paragraph 6 below).

6. Registration of Political Parties

Section 22 of the Political Parties, Elections and Referendums Act 2000 provides that no nomination may be made in relation to a Parliamentary Election unless the nomination is in respect of –

(a) A person who stands for election in the name of a qualifying registered party; or

- (b) A person who does not purport to represent any party; or
- (c) A qualifying registered party, where the election is one for which registered parties may be nominated.

A party is a "qualifying registered party" if the party was on the day ("the relevant day") which is two days before the last day for the delivery of nomination papers at that election, registered in respect of that part of Great Britain in the Great Britain Register maintained by the Electoral Commission. A person does not purport to represent any party if either the description of the candidate given in his or her nomination paper is "Independent" or no description of the candidate is given in his or her nomination paper.

7. Emblems

If a candidate who stands for election in the name of a qualifying registered party so requests, then the ballot paper will contain, against the candidate's particulars, the party's registered emblem (or one of the party's registered emblems). The request must be made by the candidate, must be made in writing to the Returning Officer, must accurately identify the emblem, and must be received by the Returning Officer before the last time for the delivery of nomination papers. The ballot paper can contain only one emblem (per candidate) registered by that Party in the Register of Political Parties.

For convenience, a form is enclosed which may be used by the candidate to request the use of an emblem.

8. Deposit

A person is not validly nominated as a candidate unless the sum of £500 is deposited by them, or on their behalf, with the Returning Officer at the place and during the time for delivery of nomination papers.

The Returning Officer will accept a deposit made either –

- (a) by the deposit of any legal tender;
- (b) By means of a Banker's Draft provided the drawer carries on business as a banker in the United Kingdom; or
- (c) In such other manner as the Returning Officer, may agree (in advance). By means of a debit or credit card or BACS transfer.

Where the deposit is made on behalf of a candidate, the person making the deposit must, at the time he or she makes it, give his or her name and address to the Returning Officer.

9. Right to Attend Nomination

Only the following persons are entitled to attend during the time for delivery of nomination papers or for making objections to them –

- (a) A person who has been validly nominated as a candidate; or
- (b) The Election Agent, proposer or seconder of such a person; or

(c) a person who is entitled to attend by virtue of section 6A or 6B of the Political Parties, Elections and Referendums Act 2000

Where a candidate acts as their own Election Agent they may name one other person who shall then be entitled to attend in place of the Election Agent.

10. Withdrawal of Candidates

Should a candidate wish to withdraw their nomination they can do so in the prescribed manner, but intimation must be made to the Returning Officer, in writing, at the Office for the delivery of nomination papers not later than 4.00 pm on Friday 7 June 2024. The Notice of withdrawal must be signed by the candidate and attested by one witness.

11. Election Agent

In terms of Section 67 of the Representation of the People Act 1983 a person must be named by each candidate as the Election Agent for that candidate. The Election Agent's name and address must be declared in writing to the Returning Officer by not later than 4.00 pm on Friday 7 June 2024. A candidate may name themselves as their Election Agent. The declaration as an Election Agent of a person other than the candidate must be made by the candidate, and must be accompanied by a written declaration of acceptance signed by the Election Agent.

The notice given to the Returning Officer must include the address of the office of the Election Agent to which all claims, notices, legal process and documents may be sent.

If no agent is named within the required time, or if the agent appointed dies and a new appointment is not made on the day of death or the following day, or if the appointment of the agent is revoked without a new appointment being made, the candidate will be deemed to have appointed themselves as their election agent.

For convenience a form on which intimation of the appointment of an Election Agent may be given is enclosed.

12. Candidates Free Copy of Register and Absent Vote List

The Electoral Commission Guidance manual contains information about using the electoral register which candidates are entitled to receive on request.

While applications would normally be made directly to the Electoral Registration Officer, to assist candidates and agents they should, if relevant, complete one application form and bring this with them when handing in their nomination papers. Staff receiving nominations will ensure that this is forwarded onto both the Electoral Registration Officers at Kilbrannan House, Bolgam Street, Campbeltown, PA28 6JY (for Argyll and Bute); and Moray House, 16-18 Bank Street, INVERNESS IV1 1QY (for South Lochaber)

The form which will be available in the nomination pack should -

- (a) specify the documents requested and
- (b) state whether a printed copy of any of the documents is requested instead of the version in data form (unless a specific request for printed copy is made it will be

provided in data form).

As noted above there are restrictions on the use of the full Register supplied to candidates as follows:-

No candidate or election agent who has been supplied with a copy of the register may –

- (a) supply a copy of the full register to any person;
- (b) disclose any information contained in it (that is not contained in the edited register); or
- (c) Make use of any such information,

except for electoral purposes.

Advice from the Electoral Commission is that "electoral purposes" should be defined as anything to do with the process of campaigning and getting elected. Fundraising, including by political parties, for the purposes of communicating with voters and campaigning to get elected may count as "electoral purposes". The Order applies to the period between elections and equally to people who are not members of political parties.

Any person who contravenes the restrictions in use specified above shall be guilty of an offence and liable on summary conviction to a fine not exceeding £5,000.

13. Absent Voting

All applications to vote by post and other applications and notices about postal and proxy voting must, if they are to be effective for this election, reach the Electoral Registration Officer (ERO) for the relevant area no later than 5pm on Wednesday 19 June 2024.

Applications to cancel or alter existing proxy votes must reach the relevant ERO by 5pm on Wednesday 19 June 2024.

New applications to vote by proxy (not postal proxy) must be with the relevant ERO by 5pm on Wednesday 26 June 2024. The relevant ERO offices are:

14. Polling and Counting Agents

Notification of the appointment of Polling and Counting Agents must be given to the Returning Officer by not later than Thursday 27 June 2024, although earlier notification would be appreciated. Whilst there is no restriction on the number of polling agents who may be appointed, only one polling agent will be admitted to a Polling Station on behalf of any one candidate at any one time. All persons acting in the capacity of agent must be notified in writing of the requirement of secrecy before so acting.

15. Counting of Votes

The counting of votes will take place on Thursday 4 July 2024 commencing at 10.00pm in the Sports Hall, Joint Campus High School, Lochgilphead.

16. Election Expenses

In terms of Section 81 of the Representation of the People Act 1983 the Election Agent of every candidate must deliver, within thirty five days after the day on which the result of the election is declared a return containing as respects that candidate –

- a statement of all election expenses incurred by or on behalf of the candidate; and
- a statement of all payments made by the Election Agent together with all bills or receipts relating to the payments.

In terms of Section 82 of the 1983 Act the return referred to above must be accompanied by a declaration made by the Election Agent. At the same time that the Election Agent delivers that return, or within seven days afterwards, the candidate must deliver a declaration made by him or her, unless the candidate is out of the United Kingdom when the return is delivered, in which case their declaration may be made and delivered within fourteen days after his or her return to the United Kingdom.

The completion and delivery of the return and these declarations as to election expenses is a statutory requirement.

17. Expenses Limit

The expenses limit at this election for a candidate in this constituency for the short campaign is £11,390 plus 12p for every entry in the Register of Electors to be used at the Election as it has effect on the last day for publication of the Notice of Election.

- 2A. Where a candidate commonly uses a name or names—
 - (a) that are different from the candidate's full names as stated on the nomination paper, or
 - (b) in a different way from the candidate's full names as stated on the nomination paper,

the commonly used name or names may also appear on the nomination paper; but if they do so, the commonly used name or names (instead of any other name) will appear on the ballot paper.

- 2B. But the ballot paper will show the other name if the Returning Officer thinks -
 - (a) that the use of the commonly used name may be likely to mislead or confuse electors, or
 - (b) that the commonly used name is obscene or offensive.
- 3. An elector may not subscribe more than one nomination paper for the same election.
- 4. A person whose name is entered in the register may not subscribe a nomination paper if the entry gives as the date on which he will become of voting age is a date later than the day fixed for the poll.
- 5. A candidate supported by a certificate of authorisation signed by the Nominating Officer of a political party (or someone on their behalf) may use the party name or a description allowed by that certificate and registered with the Electoral Commission. A candidate may stand on behalf of two or more different parties and use a registered joint description if supported by certificate(s) of authorisation from each of the parties. Any candidate may alternatively use the description of 'Independent', or leave the description box blank.

STATEMENT REGARDING CANDIDATE SECURITY AT THE UK PARLIAMENTARY ELECTION – 4 JULY 2024

Earlier this year the government provided funding in support of defending democracy and the election process. Part of this funding has been used to put in place private security provision for general election candidates.

Primary responsibility for security during the general election lies with policing. In the first instance, if you consider yourself to be at risk of harm, or you believe a crime has been committed, please contact your local police on 999 or 101. You can also contact your local Operation Bridger Single Point of Contact to relay concerns or issues. Police are able to fund additional patrolling in areas that might benefit from a policing focus.

Dependant on fulfilling criteria and scope, and supplementary to policing activity, the Home Office can also provide private security. This ranges from accredited door supervisors to additional private security provision, available dependant on risk. The Home Office can also provide Situational Awareness Training and Cyber Security Awareness Training beyond that provided by policing.

The Home Office will consider requests for security on a case by case basis, judging each request on its own merits.

ARGYLL AND BUTE COUNCIL (ELECTIONS) GUIDELINES ON DISPLAY OF CAMPAIGN POSTERS AND USE OF CAR PARKS

DISPLAY OF CAMPAIGN POSTERS

Commencing from the last date for the publication of the Notice of Election, and until Election Day, the Council will not object to the fixing of election posters to items of street furniture such as lighting columns, subject to the following conditions:-

- a) Election Agents' names and addresses must be advised to the appropriate Area Roads Operations Office prior to the display of election material.
- b) All posters must be backed by some form of board or card of adequate stiffness and tied with cord of sufficient strength. They must not be attached to street furniture using glue or any form of adhesive.
- c) Printed election material must contain an imprint to ensure that all organisations involved in publishing and promoting the material is listed. Further information on the requirements can be found on the Electoral Commissions website.
- d) Placing posters must not inconvenience the travelling public in terms of obscuring signs that are essential for the direction of traffic and safety. The mounting height of posters must not be less than eight feet (2.4m) above ground level.
- e) Posters must not, in any circumstances, be attached to any traffic signal post or control box, or to street furniture in central reservations and pedestrian refuge islands. For structural and electrical safety reasons, ladders should not be placed against lighting columns free standing step-ladders or other means of access should be used.
- f) Only one poster per candidate or two posters back to back, is allowed on each item of street furniture.
- g) All posters must be removed within 48 hours after polling day.
- h) Permission is granted on the understanding that those concerned indemnify the Council against any third party claim arising from the attachment.

USE OF COUNCIL CAR PARKS BY CARAVANS ETC.

Caravans may be sited in Council car parks, should space be available, for a period not exceeding 14 days immediately prior to polling day subject to the following conditions:-

- a) Where a car park is a free car park, no charge is made but, where a car park is fee-paying, the appropriate charge is levied.
- b) The caravan should not be used for sleeping accommodation between the hours of 11.00pm and 7.00am.
- c) To minimise the disturbance to residential areas located adjacent to car parks, the use of loud speakers is prohibited in connection with the use of a caravan in a Council car park.
- d) The total cost associated with the provision and removal of such caravans and other units will be borne by the promoting organisation.
- e) All associated signs and posters must be removed with 48 hours after polling day.

Display of Election Posters Campaign Material within Property Owned, Adopted or Maintained by the Council

This policy applies to the following assets owned or maintained by The Highland Council:

- Roads (including footways, cycleways, verges and remote paths) either adopted by The Highland Council as the local Roads Authority or maintained by another Service such as Housing;
- Property owned, maintained or leased by The Highland Council such as parks, recreational areas, buildings, etc. (with the exclusion of homes leased by Council tenants).

This policy also applies to parks, open spaces, and Council buildings regardless of whether they are owned, leased, or adopted by The Highland Council. This policy does not apply to campaigning materials which Council housing tenants choose to put up in the windows of homes which they rent from the Council.

Road safety is of paramount concern. The Council will permit the display of election posters on roadside verges and lighting columns within the Council area in connection with any election but only if they comply with the conditions stipulated herein.

Prior to any posters being displayed, an email must be sent to CEX.support@highland.gov.uk, for the attention of the Assistant Chief Executive of Place to:

- Seek permission to display campaign election posters,
- Agrees to indemnify the Council against any damages as a result of the display of such election posters.
- The relevant Council department where material is displayed in breach of this policy shall remove it as soon as practicable and then recharge the election agent or independent candidate to recover the costs in doing so.
- Agrees that posters, mounts, string and cable ties are removed within the 7 days following the election.

The following conditions must be met:

Campaign posters must not be displayed prior to the date of announcement of an election.

- In any circumstances must not be located upon the central reserve of dual carriageways, refuge islands in the center of roadways, traffic signal posts, control boxes or upon roundabouts.
- Be located not to interfere with the visibility required for persons emerging from side roads or private accesses.
- Posters must be located at the rear of any verge provision and in any case no closer than 1.5 metres to the running surface of any carriageway.
- Must be so mounted that the poster and mount will not afford any resistance or damage to a vehicle coming into contact with them.
- Posters attached to lighting columns must be first fixed to card of adequate stiffness
 which in turn must be tied with string or cable ties to the road lighting column. The
 mounting height of the card must not be less than 2100 mm (7 ft) above the height of
 the adjoining footway.
- The area of any poster must not exceed 0.2 sq. m, and the maximum overall vertical or horizontal dimension must not exceed 500 mm.

For statutory reasons the Returning Officer cannot be involved in controlling the display of election posters. Any questions or problems concerning this policy will be dealt with by the Assistant Chief Executive of Place via CEX.support@highland.gov.uk.
