Although we have no formal ATRs to report, we have a number of active Expressions of Interest (20) with 7 of these new requests being instigated within the time frame of this report. We view the increase in EOI and subsequent decrease in ATR a positive reflection of the support we are giving to communities to address and articulate their request without requiring them to invoke the legislation and the subsequent, often onerous for groups, process involved.

We recently ran an information session for elected members to inform them of the service on offer.

We actively signpost and direct general enquiries to our single point of contact.

We have responded to requests for training by working with COSS to deliver awareness courses to interested groups.

We work with all groups to help them develop and make their request known.

We engage with specialist Community Development officers to bring additional support that aids disadvantaged group to make their request.

We have a single point of contact that is in place to assist groups to develop their request whether they choose to develop a formal or informal process to raise their request.

We have redesigned our website and are developing a more user friendly Expression of Interest (EOI) page on our website; displaying less technical and more user friendly text on the page. We are keen to promote that this is an informal option, and it is not part of the formal process which sometimes is seen as onerous. Our new website and revised webpages will make clearer the pathways of taking forward ideas and plans on council assets and Community Asset Transfer. It will include a guide of frequently asked questions and key matters for community groups to consider before they take on an asset and where they can access additional support.

We are also planning to trial some promotional opportunities for community groups to work in partnership with the Council to develop the use/future sustainability of council assets.

The existing EOI page will be continue to be updated as new ideas come forward
