ARGYLL AND BUTE COUNCIL (SPECIAL EVENT – OBAN CLIPPER) (VARIOUS ROADS, OBAN) (TEMPORARY TRAFFIC REGULATION) ORDER 2024

Argyll and Bute Council in exercise of the powers conferred on them by Section 16A of the Road Traffic Regulation Act 1984, as amended, and of all other powers enabling them to do so, being satisfied that traffic in the car parks and on the lengths of road specified in the Schedules annexed and signed as relative hereto should be prohibited, restricted or suspended for the purpose of facilitating the Clipper Race Event, and being satisfied that it is not reasonably practical for the event to be held otherwise than on a car park or on a road, and having had regard to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, hereby make the following Order:

- This Order may be cited as the "Argyll and Bute Council (Special Event Oban Clipper) (Various Roads, Oban) (Temporary Traffic Regulation) Order 2024" and shall be effective between 7th July 2024 and 22nd July 2024.
- 2. The Interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.
- 3. Subject to Article 7 of this Order, no person shall cause or permit a vehicle to wait or to be parked on the Sections of Road specified in Schedule 1 annexed and signed as relative to this Order ("Schedule 1") when indicated by signs during the Times and Dates of Closures specified in Schedule 1;
- 4. Subject to Article 7 and Article 8 of this Order, no person shall drive or cause or permit to be driven on the Sections of Road specified in Schedule 2 annexed and signed as relative to this Order ("Schedule 2") when indicated by signs during the Times and Dates of Closures set out in Schedule 2 to this Order;
- In accordance with Article 26 of the Argyll and Bute Council (Off-Street Parking Places and Charges) (Oban) Order 2018, subject to Article 7 of the Order, use of the parking places within North Pier Car Park, Oban which are specified in Schedule 3 annexed and signed as relative to this Order ("Schedule 3") is suspended when indicated by signs during the Times and Dates of Closures specified in Schedule 3;
- 6. Subject to Article 7 of the Order, no person shall cause or permit a vehicle to wait or to be parked except for service buses on the Sections of Road specified in Schedule 4 annexed and signed as relative to this Order ("Schedule 4") when indicated by signs during the Times and Dates of Closures specified in Schedule 4;

- 7. Nothing in this Order shall apply to any vehicle which:
 - a) is being driven upon the direction or with the permission of a police officer in uniform, Piers & Harbours Staff of Argyll and Bute Council, the event organisers or their appointed representatives;
 - b) is an emergency services vehicle whilst attending an emergency.
- 8. Nothing in this order shall prevent any vehicle exercising vehicular access to and from the premises known as and forming Ee-Usk, North Pier, Oban PA34 5QD and Piazza, North Pier, Oban, PA34 5QD (together hereinafter referred to as "the Premises") for the purposes of (i) delivering goods to the Premises or (ii) accessing the Premises in connection with the normal operation of the business from the Premises but only (a) over that section of the U37 North Pier from its southernmost junction with the A85T in a south-westerly direction for a distance of 120 metres or thereby to the front of the Premises and (b) when safe to do so and upon the direction or with the permission of a police officer in uniform, Piers & Harbours Staff of Argyll and Bute Council, the event organisers or their appointed representatives.
