POVERTY AND COST OF LIVING CRISIS

1. Austin and Hope Pilkington Trust

Grants up to £5,000 are available to registered UK charities that work with communities in the UK for projects that address specific categories set out by the Trust each year. In 2024, the focus in rounds 3 & 4 is on Food Poverty given the increasing levels across the UK. Round 3 Opens 01 July 2024 – 31 July.

2. Pets Foundation - Preventing Pet Relinquishment Grants

Grants of up to £80,000 per year are available for projects which aim to keep pets with their owners and out of rescue, including projects providing emergency pet fostering for people facing crisis, subsidised veterinary care, neutering schemes and pet food banks.

Grants of between £20,001 and £75,000 for up to one year are available for voluntary groups, community organisations, and other not-for-profit organisations across Scotland to help support individuals, families, and communities currently experiencing hardship as a result of the cost-of-living crisis.

7. Cash for Kids Holiday Hunger Grant

Applications for Cash for Kids Holiday Hunger Grants are now open for organisations and service providers who support children and young people (up to and including 18 years old) that have a genuine need for support, are disadvantaged due to poverty, the increase in the cost of living and face food insecurity.

8. Argyll and Bute Flexible Food and Fuel Fund

Argyll and Bute Council is continuing to run a fund aimed at tackling financial insecurity for adults and families across Argyll and Bute. The Fund offers financial support and wider confidential professional help to anyone suffering hardship. Working in partnership with the Community Food Forum, Bute Advice Centre and ALlenergy, households with low incomes and no access to cash savings can apply for immediate financial support. The Fund will help support daily living expenses. **This fund is for individuals**.

Funding for the purchase of essential items to meet the most basic needs of children and young people in the UK who are facing exceptionally difficult circumstances. Where possible, items will be provided directly rather than awarding a cash grant.

Grants of up to £2,000 but only in exceptional circumstances will individuals receive a grant of more than £500 these are available for third party social organisations to support individuals and families across the UK who are in financial need and have exhausted all other sources of funding.

Groups in Scotland can apply for help with the higher costs of living. Fund is currently closed to applicants living in Wales and Northern Ireland. Applications are encouraged from Scotland
