ARGYLL AND BUTE COUNCIL (B881 HIGH STREET AND MEADOWS ROAD, ROTHESAY)(BUTE GAMES) (TEMPORARY TRAFFIC MANAGEMENT) ORDER 2024

Argyll and Bute Council in exercise of the powers conferred on them by Section 16(A) of The Road Traffic Regulation Act 1984, as amended and of all other enabling powers enabling them to do so, being satisfied that traffic on that lengths of road specified in the Schedules hereto should be prohibited or restricted for the purpose of facilitating the holding of the Bute Highland Games, and being satisfied that it is not reasonably practical for the event to be held otherwise than on a road, and having regards to the safety and convenience of alternative routes suitable for traffic which will be affected by this Order, hereby make the following Order:

- 1. This Order may be cited as the "Argyll and Bute Council (B881 High Street and Meadows Road, Rothesay) (Bute Games) (Temporary Traffic Management) Order 2024" and shall be effective when indicated by signs on the dates and times indicated in the Schedules hereto.
- 2. The interpretation Act 1978 shall apply for the interpretation of the Order as it applies for the interpretation of an Act of Parliament.
- 3. Subject to Article 5 of this Order, no person shall drive or cause or permit to be driven any vehicle through the length of road specified in Schedule 1 of this Order.
- 4. Subject to Article 5 of this Order, no person shall cause or permit any vehicle to wait at any time on the lengths of road specified in Schedule 2 of this Order.
- 5. Nothing in this Order shall apply to any vehicle, which is:
 - a) being driven upon the direction or with the permission of a police constable in uniform;
 - b) being used in an emergency for fire brigade, ambulance, police or coast guard purposes.
