Title of Proposal
Reduction in Grounds and Environment budget

Intended outcome of proposal
A reduction in the resource available to carry out maintenance of amenity areas, including sports pitches. This will result in a reduction of maintenance of grassland areas, floral bedding maintenance and cleanliness, the removal of litter from grassland and floral bed locations.

Description of proposal
Argyll & Bute Council have further funding reductions for the financial year 2019/2020, in delivering these financial savings it has been identified that the Grounds and Environment operations will make a saving of 10%. This will see a further reduction on a service that has already experienced a funding cut of 46% since 2013. Work schedules will be reduced to accommodate these proposed savings and further specification reductions.
