

ROADS (SCOTLAND) ACT 1984

ARGYLL AND BUTE COUNCIL (RALSTON ROAD, MEADOWS AVENUE AND LIMECRAIGS ROAD, CAMPBELTOWN) (REDETERMINATION OF MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE) ORDER 202_

Argyll and Bute Council, in exercise of the powers conferred on them by sections 1(1) and 152(2) of the Roads (Scotland) Act 1984, and of all other powers enabling in that behalf, hereby make the following order:

1. This Order May Be Cited As “Argyll And Bute Council (Ralston Road ,Meadows Avenue And Limecraigs Road, Campbeltown) (Redetermination Of Means Of Exercise Of Public Right Of Passage) Order 202_” and shall come into operation on Monday the ___ day of ___ Two Thousand and ___.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The lengths of footways specified in the Schedule to this Order, at present footways and verges, shall become cycle tracks the right of passage being exercisable on pedal cycle and foot only.

SCHEDULE

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED

1. That length of east footway in Campbeltown, known as Ralston Road (No. U048), currently a footway, indicated with orange hatching and marked on Drawing Number CT001-2024, commencing from its junction with Hospital Road (No.070), southerly to a point 10 metres north of its junction with Meadows Avenue (No. U 036), a distance of 108 metres or thereby.
2. That length of west footway in Campbeltown, known as Ralston Road (No. U048), currently a footway, indicated with orange hatching and marked on Drawing Number CT001-2024, commencing from its junction with Meadow Park (No.069), southerly to a point 10 metres north of its junction with Meadows Avenue (No.036), a distance of 108 metres or thereby.
3. That length of north footway in Campbeltown, known as Limecraigs Road (No. U033), currently a footway, indicated with orange hatching and marked on Drawing Number CT001-2024, commencing from a point 10 metres north of its junction with Meadows Avenue (No.036), westerly a distance of 175 metres or thereby.
4. That length of north footway in Campbeltown, known as Meadows Avenue (No.U036), currently a footway, indicated with orange hatching and marked on Drawing Number CT001-2024, commencing from a point 10 metres north of the junction with Meadows Avenue (No.036) and Ralston Road (No. U048), in a westerly direction a distance of 242 metres or thereby.
