Roberson Trust – Restructuring of Available Funds

The Robertson Trust has now reopened applications to their **Small and Large Grant Programmes**.

The Trust's rolling grants programme reopened to applications on a phased after pausing to 'Sharpen the focus' of their funds.

Through the Small and Large Grant Programmes, the Trust is now offering registered charities working in Scotland:

- **Small Grants** Revenue funding of between £5,000 and £20,000 per year for up to five years to organisations with an annual income between £30,000 and £200,000.
- Large Grants Revenue funding of between £20,000 and £50,000 per year for up to five years to organisations with an annual income between £200,000 and £2 million.

Both programmes offer unrestricted and restricted funding for a specific salary, project or service, including associated equipment costs.

Funding offered by the Trust is intended to improve the lives of people and communities experiencing poverty and trauma in Scotland. The Small and Large Grants Programme will have an initial focus on the following themes:

- Financial Security Tackling the financial and material effects of poverty on people and communities.
- Education Pathways Equipping people for the future by supporting learning and skills.
- Work Pathways Ensuring that paid work is a more reliable route out of poverty.

The Trust is currently sharpening the focus of its emotional well-being and relationships theme and expects to relaunch it later in 2024.

Wee Grants and Transport Grants also open

Earlier this year, Robertson Trust announced the opening of the new look Wee Grants and Transport Grants as of Monday, 30th September 2024.

Wee Grants offer funding of up to £5,000 for constituted community groups and charities in Scotland with an annual income of less than £30,000. This marks an increase from the previous maximum of £2,000.

The new-look Transport Grants offer increased funding of between £5K-20K per year for 1-3 years. By supporting the costs of a vehicle, or transport costs more broadly, the fund aims to help charities deliver their services and remove barriers for people and places affected by poverty and trauma. This is in recognition that a lack of access to affordable, reliable transport can impact the ability to participate in society and thrive. Wee Grants and Transport Grants are rolling funds.

Samsung's Challenge to UK Youth for Social Impact - Fund Reopens

Solve for Tomorrow is a UK-wide initiative that forms part of Samsung's global commitment to education. The company aims to empower future innovators to achieve their full potential and become the next generation of leaders to pioneer positive social change.

The competition is open to individuals or teams of up to five people aged between 16 to 25 who are resident in the UK. Participants will enter one of two groups, based on age (16-18 years-old; and 18-25 years-old).

In each group, there is a £10,000 cash prize available to develop an idea, coupled with business industry mentorship to evolve the winning concept. Two runners-up (one in each group) will be awarded £1,000, plus expert mentorship.
