

ROADS (SCOTLAND) ACT 1984

NOTICE IS HEREBY GIVEN THAT Argyll and Bute Council propose to make an order under Section 152(2) of the Roads (Scotland) Act 1984 redetermining the means of exercise of the public right of passage over the lengths of road described in the Schedule hereto.

The title of the order is "Argyll And Bute Council (Ralston Road, Meadows Avenue And Limecraigs Road, Campbeltown) (Redetermination Of Means Of Exercise Of Public Right Of Passage) Order 202_"

A copy of the proposed Order and accompanying plan (Drawing No. CT001-2024) that indicates the lengths of footways over which the means of exercise of the public right of passage is to be re-determined, together with a statement of reasons for making the Order can be inspected by logging on to the Council's website at https://www.argyll-bute.gov.uk/roads-and-travel/roads-and-maintenance/our-roads-regulations-and-limits or viewed during normal office hours at:-

Any person may, within 28 days from 8 November 2024, object to the making of the Order by notice in writing to the Head of Roads & Amenity Services, 1A Manse Brae, Lochgilphead, Argyll PA31 8RD. Objections should state the name and address of the objector, the matters to which they relate and the grounds on which they are made.

SCHEDULE

ROAD OVER WHICH MEANS OF EXERCISE OF PUBLIC RIGHT OF PASSAGE IS TO BE REDETERMINED

- That length of east footway in Campbeltown, known as Ralston Road (No. U048), currently a footway, indicated with sawtooth hatching and marked on Drawing Number CT001-2024, commencing from its junction with Hospital Road (No.070), southerly to a point 10 metres north of its junction with Meadows Avenue (No. U 036), a distance of 108 metres or thereby.
- That length of west footway in Campbeltown, known as Ralston Road (No. U048), currently a footway, indicated with sawtooth hatching and marked on Drawing Number CT001-2024, commencing from its junction with Meadow Park (No.069), southerly to a point 10 metres north of its junction with Meadows Avenue (No.036), a distance of 108 metres or thereby.

- 3. That length of north footway in Campbeltown, known as Limecraigs Road (No. U033), currently a footway, indicated with sawtooth hatching and marked on Drawing Number CT001-2024, commencing from a point 10 metres north of its junction with Meadows Avenue (No.036), westerly a distance of 175 metres or thereby.
- 4. That length of north footway in Campbeltown, known as Meadows Avenue (No.U036), currently a footway, indicated with sawtooth hatching and marked on Drawing Number CT001-2024, commencing from a point 10 metres north of the junction with Meadows Avenue (No.036) and Ralston Road (No. U048), in a westerly direction a distance of 242 metres or thereby.
