# Argyll and Bute Council announce the launch of the Strategic Events and Festivals Fund on 7<sup>th</sup> October – Deadline: Monday 18<sup>th</sup> November at 12 noon

The fund is open to not-for-profit organisations delivering an event or festival of strategic importance in Argyll and Bute between 1<sup>st</sup> April 2025 and 31<sup>st</sup> March 2026; and aims to support events and festivals to add value and increase their resilience, sustainability and growth.

Applications can be made for **up to 20% of the total cost** of the event/festival. Please note that there will be one call for applications for this period.

To maximise the limited budget available and demonstrate best value, requests should be made for the minimum amount needed to deliver the event/festival. It is expected that most applicants will seek **between £2,500 and £5,000**.

#### The maximum amount that can be applied for is £30,000.
