Consultation / engagement

Education approached HSCP as all referrals come from them and an audit shows the demands for this support has been reduced as a result of more children being eligible for 1140hrs. Child Minders and partner nurseries have been advised that this saving may be taken. They could then increase private clients.

Data		

The financial spend against this budget since the introduction of 1140hrs has reduced greatly. In 2022/23 it was £61,537 and commitment for the first 3 financial quarters this year is £32,355.

The average length of placement for a child has fallen from 110 days in 2020/21 to 22 days in the current year.

To date this session Positive Start placements have totalled: 80 days in Bute and Cowal 218 days in Helensburgh and Lomond 117 days in Mid Argyll, Kintyre and Islay 0 days in Oban Lorn and the Isles

Other information

Scottish Government has plans to further increase eligibility of 1 and 2 year olds for funded childcare. This would see referrals for this service reduce further. Under current guidance the early years service can and does offer discretionary placements for 2 year olds who would benefit from early access to childcare but whose parents do not meet the criteria. There are no plans to end this practice.

Referrals come from situations that arise from Child Protection Issues or concerns about failure to thrive or wellbeing for children birth to 3, the removal of this funding means that these children could not in future be placed with a childminder for a short and fixed period of time and instead would require to be supported by the referring agency- Social work and or Health. There is a risk that removing this funding and service will be seen as reducing early intervention approaches, although this is a non statutory provision for Education.
